1. About these terms

These Terms and Conditions apply to your access to and use of the Oryzo website (the Site). The Site is operated by Lusion (we, us, our). By using the Site, you agree to these Terms. If you do not agree, you must not use the Site.

2. About the Site

3. Changes to the Site and these Terms
